## QuayStreet Balanced Fund

This fund update was first made publicly available on 30 July 2026.

### WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the QuayStreet Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### DESCRIPTION OF THIS FUND

The QuayStreet Balanced Fund invests in a diversified portfolio with a balance between fixed interest and growth assets. The investment objective is to provide a level of return above the fund's benchmark over the long term.

### WHAT ARE THE RISKS OF INVESTING?

#### Risk indicator for the QuayStreet Balanced Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

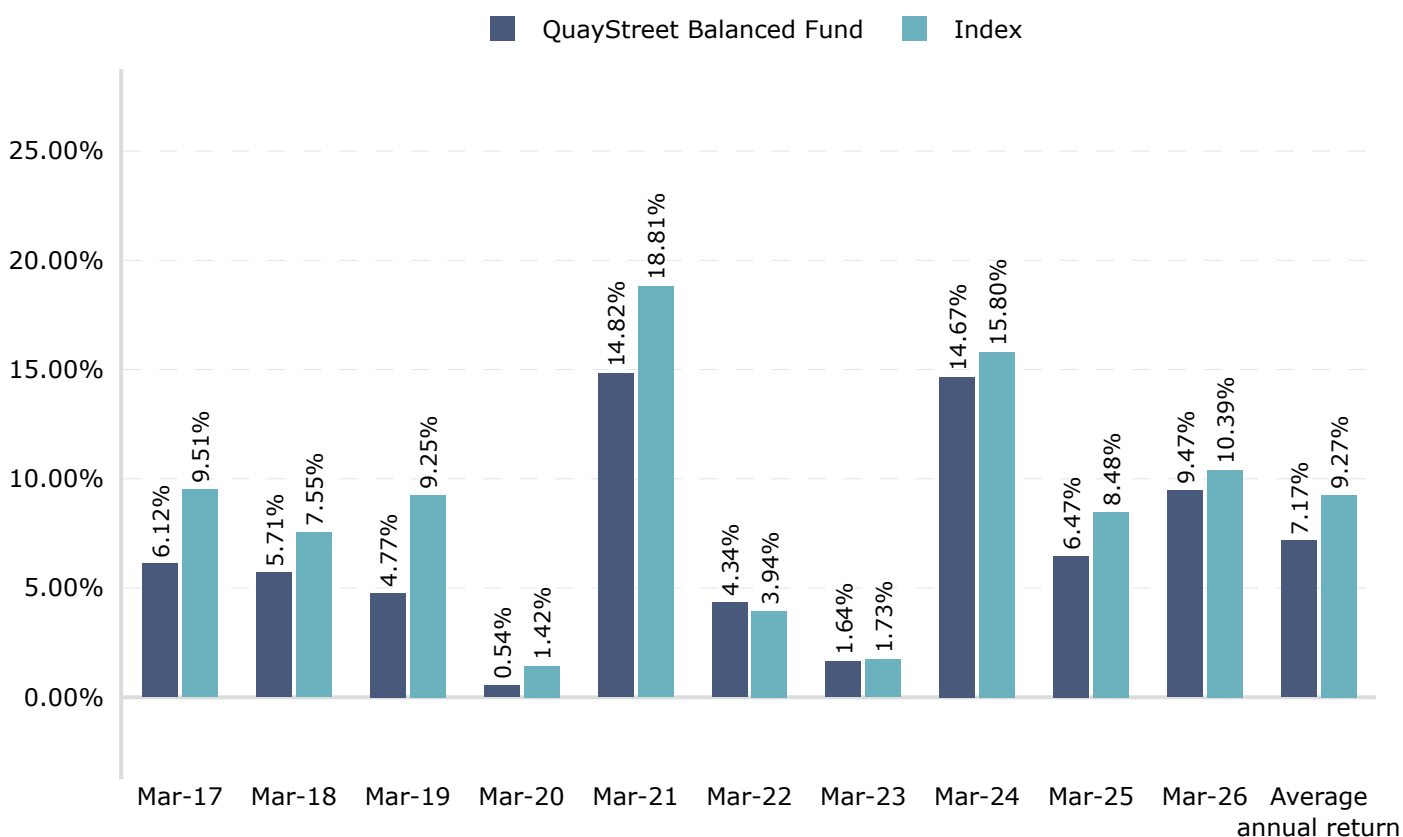

## EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

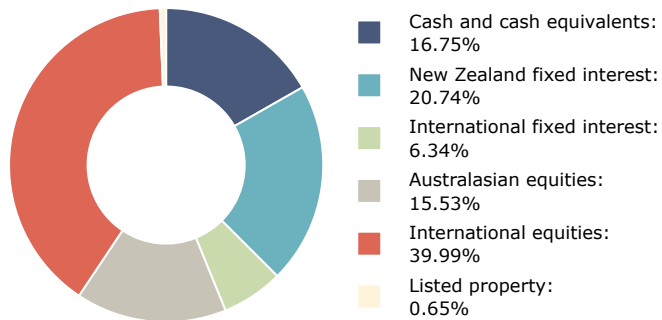
Small differences in fees and charges can have a big impact on your investment over the long term.

Emma had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Emma received a return after fund charges were deducted but before tax of \$1,165 (that is 11.65% of Emma's initial \$10,000). This gives Emma a total return after tax of \$1,095 for the year.

### Currency hedging

The fund's foreign currency exposure is actively managed in a manner consistent with the investment objectives and the performance benchmark of the fund. As at 30 June 2026, the fund's exposure to assets denominated in foreign currencies was 60.50%, of which 51.49% was hedged. This means the fund's unhedged foreign currency exposure was 29.35% of the net asset value of the fund.
